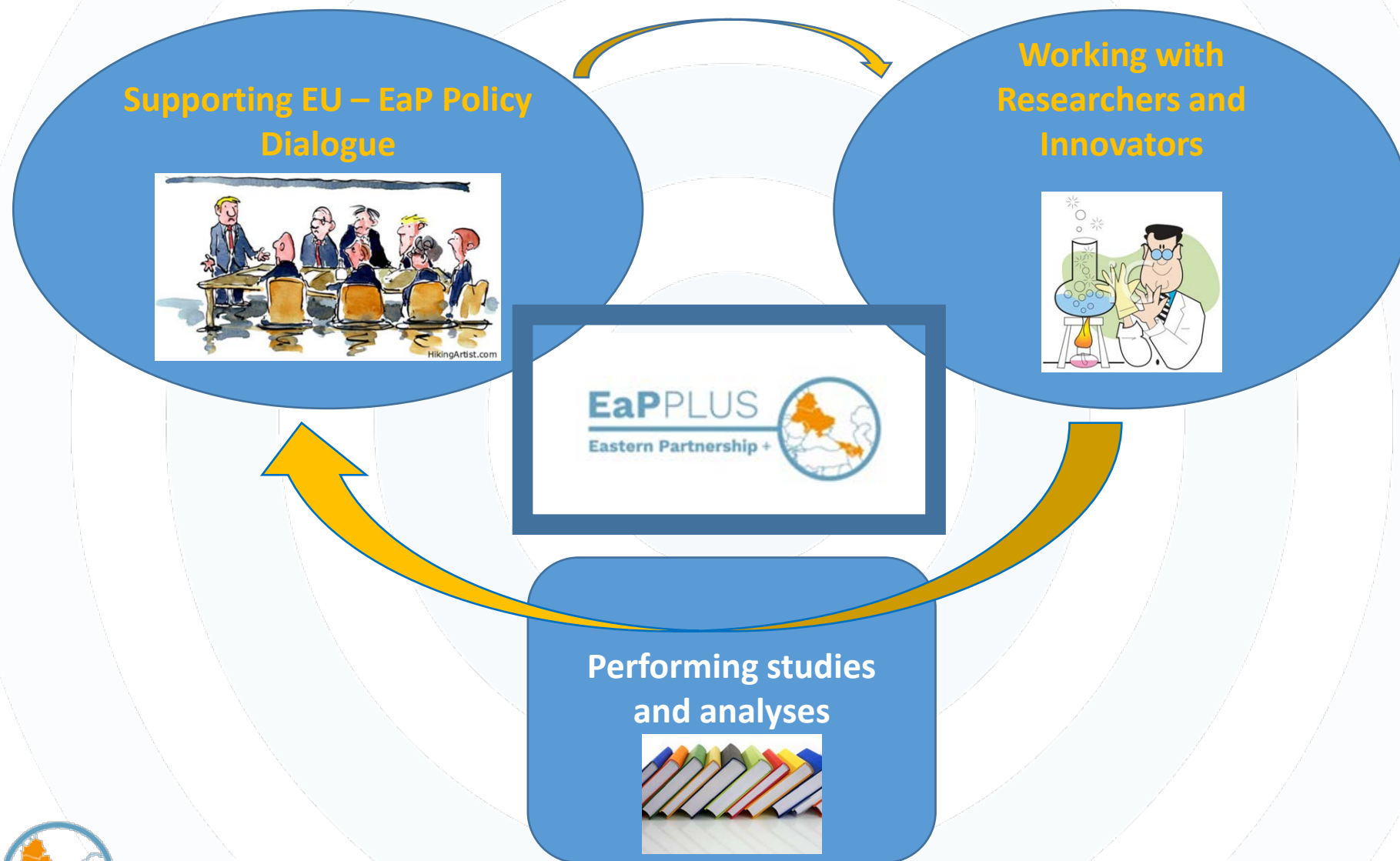

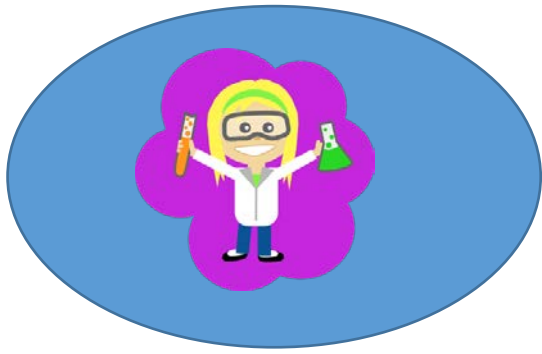


The EaP PLUS project

- A 3-year long **Coordination & Support Action** dedicated to the EU – EaP STI cooperation
- Builds on previous projects addressing the region (IncoNet EaP, Bilat, BS-Eranet, BSH, etc.)
- Includes partners from EaP countries and from several EU MS
- EaP PLUS: **a multi-level support action...**

- Providing '**Grants for Networking**' with EU researchers

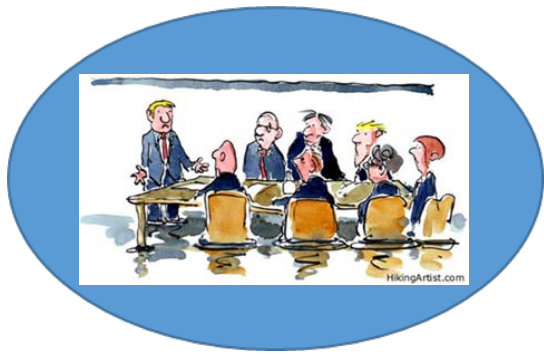


Supporting the EU – EaP Policy Dialogue in STI

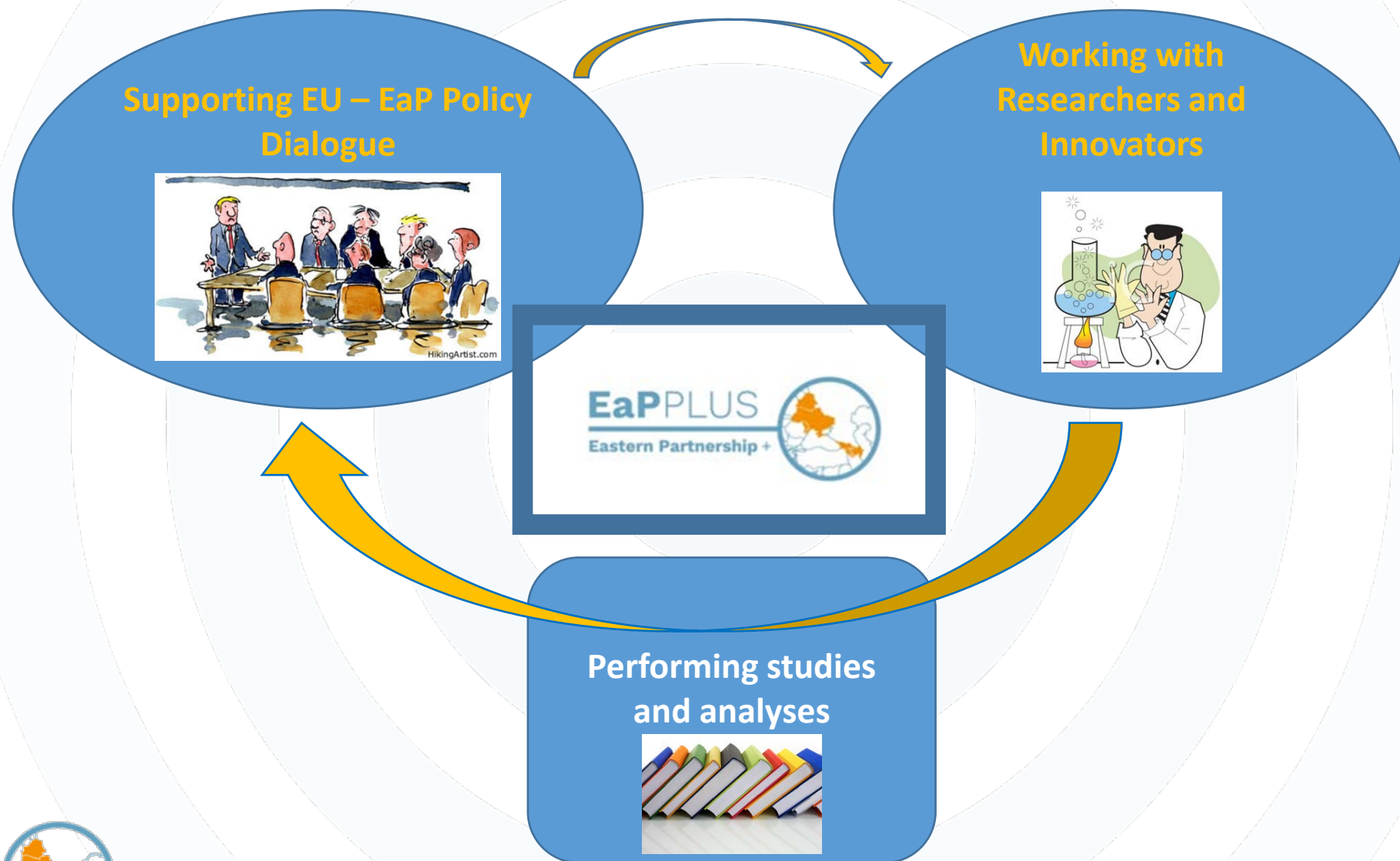

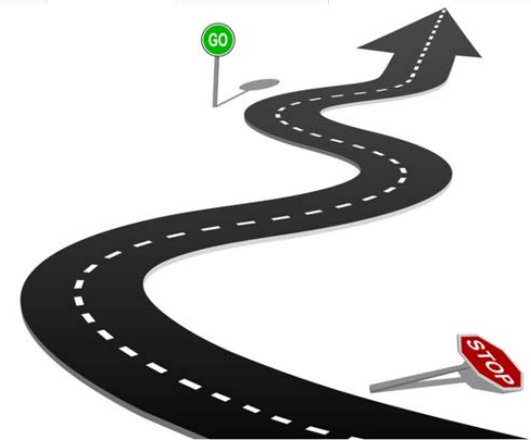
